Initial Data Analysis: SCHOOL CLIMATE

(Students in grades 3-6) rated overall school climate 3.02 (on a 4.0 scale). 45% responded "always or often" on the "I like school" question. 37% responded "always or often" on the question, "Students in my class behavior so that teachers cant teach". 59% responded "always or often" on the questions "I feel like I do well in school".

(Students in grade 7-12) rate overall school climate 2.86 (on a 4.0 scale). The lowest score was on "Students are recognized frequently for good behavior" 53% responded strongly/ somewhat agree. The second lowest score was on "School is a place I feel safe" where 55% responded strongly/somewhat agree.

The District's K-12 NCE average for STAR Math was 42.2

The District's K-12 NCE average for STAR Reading was 37.1

HIGH SCHOOL

- * Oakridge Public Schools Mean SAT score is 921.1 which is 0.1 below the 921.3 Muskegon County mean and 38.8 below the 959.9 Statewide Mean.
- * 48.6% (51 of the 105 students assessed) of 11th grade students from Oakridge High School (zero Fusion students assessed) met or exceeded the benchmark score of 480 on the Spring 2023 SAT Evidence based Reading and Writing and the mean score was 477.0. *15.2% (16 of 105 students assessed) of 11th grade students from Oakridge High School met or exceeded the benchmark score of 530 on the spring 2023 SAT Math and the mean score was 435.2.

Initial Initiative Inventory and Analysis: Oakridge has focused on implementing our Eagle Strategic Plan 3.0 approved July of 2022. The full version is on our website at www.oakridgeschools.org/strategic-plan . A summary of existing efforts and initatives include:

A. Academic Success - Improve students' academic proficiency.

- 1. Curriculum: (a) Establish coherent written curriculum maps aligned to state standards for all courses. (b) Establish horizontal and vertical alignment of curriculum across and between grade levels. (c) Ensure the curriculum is developmentally responsive, rigorous, and relevant to our students. (d) Embed literacy, critical thinking, and problem-solving skills across disciplines.
- 2. Instruction: (a) Provide an engaging and rigorous instructional experience aligned to state standards and adapted to students' unique needs/talents.
- 3. Assessment: (a) Implement district assessment and progress monitoring protocols with fidelity. (b) Improve educators understanding and use of student assessment data to inform instruction and target interventions.

- 1. Inspire students to be active participants in pursuing their pathway to be enlisted in the military, employed in the workforce, or enrolled in post-secondary education.

Gap Analysis: District Climate

Improve overall school climate for students in grades 3-6 from 3.02 (on a 4.0 scale) to 3.25 by Spring of 2025. Improve students who responded "always or often" on the "I like school" question from 45% to 55% by Spring of 2025. Improve students who responded "always or often" on the questions "I feel like I do well in school" from 59% to 65% by Spring of 2025. Improve overall school climate for students in grade 7-12 from 2.86 (on a 4.0 scale) to 3.0 by Spring of 2025.

The District's K-12 NCE average for STAR Math was 42.2 in Fall 2023. Will increase 5 points by Fall 2025 to 47.

The District's K-12 NCE average for STAR Reading was 37.1 in Fall 2023. Will increase 5 points by fall 2025 to 42.

- *26.1% of 8th grade students were advanced or proficient on the Spring 2023 PSAT Math. Will increase 5% points to 31% by Spring 2025.

Upper Elementary

- *31.9% of 4th grade students were advanced or proficient on the 2023 ELA M-STEP. Will increase 5% points to 37% by Spring 2025.
- *35.2% of 5th grade students were advanced or proficient on the 2023 ELA M-STEP. Will increase 5% points to 40% by Spring 2025.
- *32.5% of 6th grade students were advanced or proficient on the 2023 ELA M-STEP. Will increase 5% points to 38% by Spring 2025.
- *23.6% of 4th grade students were advanced or proficient on the 2023 Math M-STEP. Will increase 5% points to 29% by Spring 2025.
- *15.6% of 5th grade students were advanced or proficient on the 2023 Math M-STEP. Will increase 5% points to 20% by Spring 2025.

Lower Elementary

District Data Story Summary: Students are not performing academically, behaviorally, or emotionally up to their potential.

We have a strong foundation of initiatives rooted from stakeholder input via our strategic planning process. Research supports our practices aimed for growth and improvement with existing staff capacity. We lack sufficient personnel to add capacity (people and programs) to our current efforts. With additional funds, we can add capacity.

Summary: EdTrust defines expanded learning time (ELT) as programs or strategies implemented to increase the amount of instruction and learning students experience. ELT strategies include afterschool, summer, and in-school programs. The evidence suggests that extended learning time programs, including extended school day (ESD), extended school year (ESY), and expanded learning opportunities (ELO) programs that provide academic services during out-of-school time hours, can be effective in improving a range of educational outcomes for students. Findings also suggest that extended learning time programs may be more advantageous for low-income, low-performing, ethnic minority or otherwise disadvantaged students.

Summary: A trained adult advocate can help students who have fallen off track by providing individualized support to meet their academic, personal, and emotional needs. An advocate is a student's "go-to person" for the resources and support needed to graduate, and typically provides these supports for the entire time a student is enrolled in the school, or, at a minimum, for a full school year. Advocates can be school staff or not employed by the school district. Advocates can identify unmet needs and provide or coordinate more intense, individualized support to help students get back on track for graduation.
